Strategic Plan Progress

Goal 1: Create and Sustain Affordable Housing

- ▶ Arlington's Moderate Income Purchase Assistance Program (MIPAP) provided downpayment and closing assistance to 4 low-income first time homebuyers to assist in purchasing their first home. Loans totaled \$234,500.
- ▶ Rebuilding Together provided maintenance and repairs to 19 homes occupied by low and very low income individuals, including five group homes occupied by 24 disabled individuals.

Goal 2: Promote Healthy and Self-Sufficient Families

- ▶ B2i's Bridge to Work program enrolled 38 people in a job training program, 16 of those participants who were formerly unemployed found a job and 4 participants increased employment income and/or benefits as a result of program.
- ▶ Edu Futuro served 113 students through its Emerging Leaders Program (ELP), including 10 through the ELP II which prepares high school seniors for college. 9 of the 10 ELP II participants graduated from high school and enrolled in college and 8 secured financial aid.

Goal 3: Stabilize Households at Risk of Homelessness

- ➤ ASPAN's Supportive Housing project provided case management support to eight chronically homeless individuals and veterans, enabling them to remain in permanent supportive housing throughout the grant period.
- Arlington Thrive's Daily Fund provided emergency assistnace to 398 households, preventing these households from eviction and/or from becomming homeless.

Goal 4: Foster Vibrant and Sustainable Neighborhoods

- ➤ County staff conducted 41 educational workshops for tenants and homeowners, educating 1,400 residents on landlord-tenant rights and responsibilities, fair housing, property maintenance, and homeownership.
- Neighborhood cleanup events took place in Nauck and Arlington Mill neighborhoods, where 473 residents participated.
- ➤ County staff inspected 283 committed affordable units for housing standards/code compliance.

What's Next in FY 2019

- ▶ Two multifamily projects, the renovation of The Carlin Apartments and development of Trenton Street Apartments, are planned for County Board approval in FY 2019 using CDBG and/or HOME funds. If approved, Arlington will extend the affordability period for 161 existing committed affordable units (CAFs) and add 97 new CAFs to its affordable housing portfolio.
- ▶ Volunteers of America Chesapeake (VoAC) will repair a group home that currently houses 5 adults with intellectual disabilities using CDBG and HOME CHDO funding.
- ▶ A Client Services Specialist will provide direct program and case management support to families who are served by Bonder and Amanda Johnson CDC in Nauck.
