#### When?

Census Count Day is April, 1 2020, and people can start responding to the Census online, by phone, or paper starting as early as March 12, 2020.

#### Who?

Every person at your address needs to be counted regardless of age, relationship, or status. Too often people with lower incomes, millennials, children under five, people with limited English language, and renters are undercounted in the Census.

#### What?

The Census is a count of every person living in the United States every 10 years.

#### How?

The U.S. Census Bureau will send an invitation to every address by mid-March, 2020. It's important that everyone participates online, by phone, or with a hard copy form.

#### Why?

A fair and accurate census count is the heart of our democracy. It is the basis for determining legislative representation, helps us plan for needs and services, and is the basis for federal funding. Arlington County receives millions of federal dollars for transportation, public safety, education, health and human services and more.
