

**EXTENSION OF MEMORANDUM OF AGREEMENT OF
UNDERSTANDING BETWEEN THE U. S. DEPARTMENT OF STATE
AND THE COUNTY BOARD OF ARLINGTON COUNTY, VIRGINIA**

This Extension of Memorandum of Understanding (“Extension”) is made this 11 day of June, 2018, by and between United States Department of State (“DOS”), and the County Board of Arlington County, Virginia (“Arlington County”). DOS and Arlington are hereinafter sometimes jointly referred to as the “Parties.”

RECITALS

WHEREAS, by an Amended Memorandum of Understanding (“Amended MOU”) between DOS and Arlington County (attached as Exhibit A), DOS and Arlington County agreed to terms and conditions for the temporary joint recreational use by the parties of the parcel of the federal property west of George Mason Drive (“West Parcel”) and a portion of the parcel of federal property east of George Mason Drive (“East Parcel”) at the site of the National Foreign Affairs Training Center (“NFATC”);

WHEREAS, Subsection III.B.1. of the Amended MOU provides that the Amended MOU shall remain in force for a minimum of ten (10) years from the date of signature;

WHEREAS, the last date of signature on the Amended MOU is July 30, 2008;

WHEREAS, pursuant to the provisions of Subsection III.B.1. of the Amended MOU may be extended in five (5) year increments with the acceptance of all parties; and

WHEREAS, the Parties have mutually agreed to extend the Amended MOU for an additional five (5) year increment.

EXTENSION

NOW, THEREFORE, in consideration of the foregoing, the mutual premises herein contained and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereto, intending to be legally bound, agree as follows:

1. Extension. The term of the Amended MOU is hereby extended for a period of five (5) years. The term, as extended, shall expire on July 30, 2023, unless further extended or earlier terminated pursuant to the terms and conditions of the Amended MOU.

2. Acknowledgement of East Parcel Termination. The Parties hereby acknowledge that DOS has unilaterally terminated all County joint public recreational use of the East Parcel, pursuant to DOS’s rights under Subsection II.K. of the Amended MOU.

3. Confirmation of Terms. All other the terms, covenants, and conditions of the Amended MOU shall remain in full force and effect, and are hereby adopted and reaffirmed by the Parties hereto.
