Some seem supportive of the school psych and social workers, but in general there seems resistance to using one-time funds to add new staff. About an hour in to Part 2, it switches to the conversation on the CIP

#### Anne O'Brien shared:

"One thing I think that is especially important to note (and was reminded of this last night) is the under-representation of Hispanic and Black students in gifted/talented, AP/IB and especially calculus courses (there is also under-representation of Hispanic students in physics and chemistry, though not for Black students). As upper-level math and science courses are the gateway to post-secondary education, it's an interesting thing to consider.

Also interesting is the disparities in in- and out-of-school suspension rates. I know that at least in the last report card, the suspension data was shown by the percentage of each student population who had been suspended, but I think comparing the percentage of suspensions by each student population to school/district demographics presents a much richer picture for discussion (ex: black students make up 10.6% of students but 29.5% of suspensions...why?).
