Data Updates:

- Community Report Card
 - We're beginning to work on how we'll be reporting data for the community, through a series of dashboards and links, but providing supporting documentation in the way of "white papers" that will help make connections that will help inform programs and policy. There will be a meeting on July 9th to further discuss the plan and timeline for all those that are interested.

- Data Sharing
 - The Data Committee met with folks from CSC, BOP, CIS, School Health and others to talk about initiatives that are currently sharing data in some form. Later in July, there will be a meeting to look regionally or nationally for other models that currently share data

with the goal of making recommendations per our Advocacy Letter to the County Board in March.

Other Misc. Updates:

Mental Wellness Committee is working on a mapping process of who is doing what in the area of youth mental health. The resource will include APS, County and private services and information. If you have any resources or information to share, please do so by July 11th. We will pull together a list of everything we have and work later in July to have something drafted.

HCAT met and thanked Mary Wulf, Coordinator for the past two years for her efforts. She will not be continuing as Coordinator for this next phase of the Strategic Plan Implementation for which the Virginia Foundation for Healthy Youth has awarded \$30,000.00 for the next two years. The Co-Chairs, Kara Blankner and Aisha Salazar, have interviewed several highly qualified candidates and hope to have someone selected by the end of this week. The 2018-2020 Workplan is available for anyone as a handout at the meeting this evening.

Child Care Initiative is now working on the Implementation Plan and have identified short-term, medium-term, and long-term goals. On July 24th, the group will be presenting the plan for approval to the County Board. Once that is approved, the work in earnest will begin.

Destination 2027 is now looking at selecting/narrowing down the field of issues. During the last meeting, we discussed the criteria framework to select among the proposed strategic issues. Two Gated Criteria are in this table. If an issue meets this criteria, then it may move forward to the next step of criterion.

The questions in the table below are examples of how the criteria could actually be applied:

Pre-requisite/Gated Criteria	Example Question(s) to apply
Health Equity	Does the issue proposed disproportionately and unfairly impact parts of my/our community?
Systems Approach	Is this proposed issue more upstream than downstream? (https://www.youtube.com/watch?v=qarQXqKbmLg)
