Preliminary Audit Assignments

The Committee reviewed and discussed the list of 33 audit suggestions provided by the Advisory Commissions, the County Auditor, and the County Manager. The Committee members reached a consensus on the first assignments:

- Site Plan Conditions: Tracking, Monitoring, and Enforcement
- Jail Medical Services: January 2006 Recommendations Follow-up
- Emergency Medical Services (Ambulance) Fees: Contract Oversight and Revenue Management It was agreed that the three preliminary audit assignments would be included in the County Auditor's draft Fiscal Year 2017 Audit Plan, which will be presented at the next Audit Committee meeting.
