Background Information

The Colonial Craftsman dwelling at 3301 21st Avenue North was built before 1923. The *Maywood National Register Nomination* describes the house as follows:

The two-bay-wide, wood-frame dwelling rests on a solid, brick-stretcher foundation. It is clad in asbestos siding and has a hipped roof sheathed in asphalt shingles. It has a one-story, two-bay, wood-frame front porch on Tuscan columns and one-over-one vinyl-sash windows. Window and door surrounds are unmittered with a projecting sill and a cyma lintel. Other notable features include a shed-roof dormer, a wood cornice with a beaded-board soffit. shutters, and a massive two-and-a-half-story, vinyl-clad rear addition.

The subject dwelling is listed as a contributing resource to the Maywood National Register Historic District.

Proposal

The applicant requests to replace the entire existing three-tab asphalt shingle roof with an architectural asphalt shingle roof. There are no other roofing materials (standing seam or stamped tin) located on the dwelling.

DRC Review

The Design Review Committee (DRC) heard this application at its July 2018 meeting. The committee had no comments and recommended that the subject application be placed on the consent agenda for the July 18, 2018, HALRB hearing.

Recommendation

Staff recommends approval of the application as the architectural shingle roof is appropriate for the Maywood Local Historic District, continues the established precedent of permitting the use of architectural asphalt shingle instead of three-tab asphalt shingle, and complies with Chapter 5: Exterior Renovation of the *Maywood Design Guidelines*.
