1. WELCOME AND CALL TO ORDER

The regular meeting of the Arlington Economic Development Commission was called to order by Chair Duran at 8:06 AM. County Board Liaison Libby Garvey was welcomed to the meeting.

2. APPROVAL OF MINUTES

Motion made by Commissioner Poli seconded by Commissioner Norris to approve the minutes of the January 9, 2018 meeting. Motion carried unanimously.

3. CHAIR'S REPORT

- Chair Duran reminded members to turn in their Financial Disclosure statements to the County Board Office as required by the Commonwealth of Virginia.
- She congratulated Commissioner Familiant on his promotion to the General Manager of the McLean Hilton. However, because the property is not in Arlington County, he will be resigning his EDC seat.
- Duran asked Commissioners to review the Electronic Participation policy (see Attachment 1) and come prepared to consider it at the next meeting.

- AED Assistant Director Alex lams provided updates (supplemented by information from Commissioner Bates) on the TOT surcharge.
- lams reported that staff is working on the Amazon HQ2 project following on the announcement that Northern Virginia is among the top 20 finalists. He also reported that the County Board recently authorized two gazelle grant projects for Higher Logic, a software company that will expand in Rosslyn, and Axios, a digital media company that will expand in Clarendon.
- Trade shows are planned in March (SXSW) and May (Collision) to promote Arlington as an innovative community for startups and technology companies.
- Beginning February 7th, BizLaunch will be offering Financial Business Counseling via our partnership with the Latino Economic Development Center (LEDC) on Wednesdays

- Strategic Plan for Economic Development of the Commonwealth Stephen Moret, CEO of the Virginia Economic Development Partnership (VEDP) presented the new strategy and discussed efforts to regain Virginia's reputation as a leading business location (see Attachments 2 and 3).
