Background Information

The Colonial Revival dwelling built pre-1293 at 3505 22nd Street North is in the Maywood Historic District. The National Register Nomination describes the building as follows:

The three-bay-wide, wood-frame dwelling is clad in asbestos shingles and has a hipped roof sheathed in pressed metal shingles. It has a one-story, four-bay, wood-frame wrap-around front porch on Tuscan columns and nine-over-one wood-sash windows. Window and door surrounds are unmittered with a projecting sill and a molded lintel. Other notable features include a hip-roof dormer with a single hinged sash with diamond panes, a bay window on the east elevation, a standing-seam metal roof on the porch, and a beaded-board in the soffit.

The subject dwelling is listed as a contributing resource to the Maywood National Register Historic District.

Proposal

The applicant requests to install a metal railing on the concrete stair/step on the south side of the property leading from the public right-of-way to the front porch. The railing would be a standard height and consist of 1" solid square posts and a 134" molded top rail.

DRC Review

The Design Review Committee (DRC) heard this application at its September 2018 meeting. The committee had no comments and recommended that the application be placed on the consent agenda for the September 19, 2018, HALRB hearing.

Recommendation

Pending submission of additional documentation, the Historic Preservation staff recommends approval of the application as the design and material of the railing are appropriate for the Maywood Historic District and comply with Chapter 7: Site Elements of the *Maywood Design Guidelines*.
