L. Call to Order

The meeting was called to order at 9:00 a.m., by Chairman Mary Dooley, in Azalea Room 103 of the Arlington County Administrative Offices, 2100 Clarendon Boulevard, Arlington, Virginia 22201.

II. Case Hearings

CASE 19-51 Hearne Steven G & Kelley T Hearne

2612 N Lexington St RPC: 01-075-015

Steven Hearne was in attendance and presented the case to the Board.

Jorge Yabar, Arlington County appraiser and Derek Dubbe, Arlington County residential supervisor appraiser with the Department of Real Estate Assessments presented the case for the county. After a review of the assessment resulted in a reduction from \$1,197,500 to \$1,171,700, the county recommended that the Board confirm the assessment of \$1,171,700.

Decision and Rationale: Jose Penaranda moved to confirm the county's assessment of \$1,171,700. Mary Dooley seconded. The motion passed, 5-1, to confirm the county's assessed value of \$1,171,700. Barnes Lawson was the lone dissenting vote. The rationale was a lack of compelling evidence to make a change to the county's valuation.

CASE 19-144 Bruce & Danielle Arthur

Since the county agrees with the appellant's recommended value, Travis Shelton, Arlington County appraiser, and Derek Dubbe, Arlington County residential supervisor appraiser, requested that the Board reduce the assessment to the appellant's estimate of value, \$579,300. With agreement from the appellant, Bruce Arthur,

Mary Dooley moved to reduce the assessment to \$579,300. Barnes Lawson seconded. The motion passed, 6-0, to reduce the assessment.

The county's agreement with the appellant was based on equalizing the appellant's tax burden for 2019 with that of his neighborhood. While the appellant's property data was correct for 2019, the property information for the appellant's neighborhood was incorrect, creating an imbalance in the tax burden that has been corrected moving forward.

Charles Sensibaugh was in attendance and presented the case to the Board.

Derek Dubbe, Arlington County residential supervisor appraiser with the Department of Real Estate Assessments, presented the case for the county. After a review of the assessment resulted in a reduction from the original assessment of \$1,285,500 to \$1,214,700, the county recommended that the Board confirm the assessment of \$1,214,700.

Decision and Rationale: Mark Yates moved to confirm the county's assessment of \$1,214,700. Jose Personnel a seconded. The motion passed, 6-0, to confirm the county's assessed value of \$1,214,700. The rationale was a lack of compelling evidence to make a further change.
